# **HIGHLIGHTS**

In a first for the Legislature, HSTA passed <u>HB 184</u>, Discrimination; Gender ID; Sexual Orientation sponsored by Rep. Josephson from committee. It was the first time a committee has approved any measure banning discrimination against lesbian, gay, bi-sexual, transgender and queer Alaskans.

Rep. Tarr and Sen. MacKinnon held a screening for legislators and staff of the HBO documentary <a href="IAm Evidence">IAm Evidence</a>. Produced by Law and Order SVU Actress Mariska Hargitay, the film tells the story of four survivors whose rape kits went untested for years as they navigate their way through the criminal justice system.

Sen. Kevin Meyer, the Chair of the Senate State Affairs Committee, attended the film screening and scheduled a hearing on <u>HB 31</u>, Sexual Assault Training & Exam Kits sponsored by Rep. Tarr for Thursday, March 22<sup>nd</sup> at 3:30pm.

The Victims Advocate Selection Committee-a joint committee of the House and Senate-selected the current Victims' Advocate, Taylor Winston, to move forward for confirmation of another term of service. The Victims Advocate directs the Office of Victims Rights; serving 5-year terms at the pleasure of the Legislature.

Sen. Costello added a Monday 6:00pm SL&C meeting to the regular schedule of SL&C meetings through the end of session.

### **BUDGET ISSUES**

The Fast-track Supplemental, <u>HB 321</u>, passed both bodies. The stopgap spending plan bill includes \$45 million for Alaska Medicaid programs; \$24 million to fully fund the Alaska Marine Highway; and \$30 million for the Community Assistance Program.

The regular supplemental bill is still in play.

The operating and mental health budgets passed from HFIN on Friday. A total of 197 amendments both through the subcommittee and full committee levels were considered for the operating budget.

The bills are expected to be on the House Floor next week.

<u>HB 213</u>, Public School Trust Fund sponsored by Rep. Parish passed the House Friday. It's expected to go to the Senate after a reconsideration vote. The bill follows the percent of market value (POMV) approach allowing the state to annually spend 4.75 % of the fund's five-year average value.

HB 142, Unemployment Insurance Benefits sponsored by Rep. Tuck also passed the House. The bill would increase the state's maximum unemployment payment from \$370 per week to \$510. Alaska's current benefit is the **39**<sup>th</sup> highest in the U.S. The **\$510 amount** would raise the benefit to the **13**<sup>th</sup> highest.

For only the **6**<sup>th</sup> **time** in its 42-year history, the **Alaska Permanent Fund Corporation's** board of trustees issued advice and a warning to the Legislature. The board unanimously approved a resolution stating the multibillion dollar deficit and lessening reserves require spending from the Permanent Fund.

The resolution also says if the Legislature authorizes such spending, it should do so under an organized system, rather than on an as-needed basis. Resolution

On Monday at 9am, SFIN will hear the **Spring Revenue Forecast** from Department of Revenue Commissioner, Sheldon Fisher.

HFIN will hear from Commissioner Fisher at 1:30pm followed by Ken Alper, Director of the Tax Division and Dan Stickel, the Chief Economist.

They'll also hear about "Alaska's Economy" from Mike Navarre, Community, & Economic Development Commissioner.

HFIN will **take up the Capital budget next Friday** to hear an overview of the Governor's FY2019 proposals.

The committee will also hear <u>HB 282</u>, Capital Budget contingent on Tax. The funding for the appropriations in HB 282 depend on establishing a state payroll tax.

The tax is a small one—just 1.5 percent and capped so that no one would pay more than \$2,200. The levy would bring in \$320 million annually with most of the funds being directed toward a long-standing deferred maintenance backlog. The tax would sunset in three years.
