## Supreme Court Justice Antonin Scalia dies at 79

~ *House now under the 24-Hour Rule – They will hear budget related bills only* ~

### HIGHLIGHTS

In an unprecedented action, the **Alaska House** voted to suspend work on all bills not related to the **state budget and revenue measures**. House Concurrent Resolution 23 took effect this past Monday.

Instead of noticing committee meetings on bills five days ahead, the House can now announce a hearing the day before. There has been no indication the Senate will follow suit with a similar measure.

Earlier that same day, the democratic minorities in the House and Senate presented a proposal to their Republican colleagues for a “caucus of the whole.” In essence, share power with us so we can fix the budget crises together.

Also in the blender for this past week, is the announcement that Senator Donny Olson of Golovin has joined the Senate Majority as the 16<sup>th</sup> Majority Member. He will continue to speak for rural Alaskans.

And, the House’s Republican-led majority urged state residents to call a toll-free number and leave anonymous suggestions on how the state can save money. After a week in use, they’ve logged hundreds of phone calls. The number is 1-844-414-5949.

In his State of the Judiciary address, Chief Justice Craig Stowers of the Alaska Supreme Court touted the cost-cutting measures the court system has already undertaken. He asserted that next fiscal year they will continue to operate on half days every Friday.

Lawmakers have again delayed taking action on their renovated Anchorage offices. They have now decided to hire an independent financial expert to help them sort out competing cost analyses. It could be March or April before a final decision is reached.

The Alaska State Employees Association and the administration of Governor Walker have reached a tentative agreement on a three-year contract. The pact would have no raises and two days of furloughs a year. It must still be approved by the membership of the union and the Legislature.

The Transportation Security Administration, better known as TSA, says finding new hires in Alaska is challenging. The high cost of living, rural locations, and a skewed perception of what it’s really like to live in Alaska are all factors in finding and keeping employees.

A new report from the McDowell Group shows that the total economic impact of the ferry system was \$273 million, including south central Alaska. That system is responsible for 1,017 jobs and indirectly for 683 jobs.

The *Chuck-e-Cheese* bill has passed the Senate. Actually, the measure (**SB 157**) will ensure the state's definition of "gambling" does not include games that issue tickets for prizes. This includes the "Claw" machines that are found in stores all over the state.

### **BUDGET ISSUES**

At a press opportunity this past week, the Senate Finance Committee stated they want a budget ready for conference committee by Mid-March.

Hundreds of people have weighed in on **SB 128** relating to the Permanent Fund. Senate State Affairs has conducted a marathon of hearings on the Governor's bill that proposes to use a portion of the Permanent Fund to help balance the state budget.

Reportedly, 85 percent of comments were against the idea of using the Fund.

Another related Permanent Fund bill is **SB 114**. This bill too has received a hearing and is scheduled for a couple more this coming week. This bill and the governor's bill used some of the same financial models, so there are many similarities.

House Resources has had three hearings on **HB 247**, legislation to reform the tax credit system for oil companies.

Alaska Airlines has testified that a hike in fuel taxes as proposed in **HB 249** could adversely affect the company's operation in the state. More public testimony will be taken in House Transportation this coming week.

### **CONSTITUTIONAL ISSUES**

A nonpartisan group known as "*Justice Not Politics Alaska*" has been formed to educate people about the downsides of **Senate Joint Resolution 3**. Lying dormant since last April, it would place a constitutional amendment on the next general election ballot that would allow voters to decide whether to change the structure of the judicial council.

### **EDUCATION ISSUES**

"Kids in the Capitol", organized by Alaska Education for Young Children, was well received in the halls of the legislature this week. Kids handed out about 100 valentines and postcards to all legislators. This was a positive reminder on how important Early Childhood Education dollars are.

A Fairbanks English teacher has been elected president of Alaska's National Education Association (NEA).

### **HEALTH & SOCIAL SERVICES ISSUES**

In less than two weeks, Alaskans will be able to apply for the first commercial marijuana licenses in the state. The Marijuana Control Board has approved the forms for the applications that will begin on Feb. 24<sup>th</sup>.

The Board has also approved what they are calling an "on-site consumption endorsement." Basically allowing a store to include space specifically for smoking or consuming marijuana.

Multiple hearings in a Senate Finance Subcommittee were once again held on **SB 74 and SB 78** concerning Medicaid reform. These hearings will continue into next week.

**SB 23** was an exception to the “budget bills only rule” as it got a hearing and moved out of the House Judiciary committee. This bill would legally shield Alaskans who administer a counter-overdose injection to a person suffering a heroin or prescription painkiller overdose. After it passes the House, it will have to return to the Senate for concurrence with the House changes.

Invited testimony is next week on **HB 227** in the House HSS Committee. Medicaid related it deals with several aspects of the medical assistance reform measures.

Moda Health will be allowed to resume operating its health insurance business in Alaska and Oregon after an agreement was reached with both states.
