

# **2016 CAPITOL CURRENTS**

*29<sup>th</sup> Alaska State Legislature ~ 2<sup>nd</sup> Session*

**~ Ivy Spohnholz appointed to the House District 16 seat ~**

## **HIGHLIGHTS**

Governor Bill Walker named Salvation Army development director Ivy Spohnholz as the new representative for House District 16, replacing Max Gruenberg who died earlier this year in Juneau.

She is vice chairwoman of the Alaska Children’s Trust and has lived in Anchorage for more than 35 years. Ms.

Spohnholz was confirmed by a majority vote of House Democrats and sworn into office March 10<sup>th</sup>.

Representative Spohnholz recognized her mother sitting in the gallery behind her. Former Representative Ann Spohnholz was also appointed to a House seat in 1989.

Trial by fire. On her first day, the House Floor session lasted until 3:30 a.m. as numerous floor amendments were considered and all voted down.

After losing in the Superior Court, the Legislature may continue their battle against Medicaid expansion. It will probably cost \$250,000 or more to pursue a lawsuit that every judge has thrown out.

The House Speaker refused to allow debate or a vote when an amendment came forward to revoke money for the appeal to the Alaska Supreme Court.

He said it was out of order because the lawsuit was “awaiting adjudication in court” – even though the case was dismissed this past week.

Disabled Alaskans can save more money without affecting their state and federal benefits under a bill pending in the Alaska House. Although introduced last year, the sponsor finally got a hearing for the idea.

**HB 188** would allow Alaskans to make use of the federal Achieving a Better Life Experience, or ABLE, law, designed to allow disabled people and their families to contribute to tax-free accounts for expenses like education, housing and transportation.

## **BUDGET ISSUES**

Many economists and financial experts are saying the same thing – We’re headed for a deep recession.

Even if the Legislature makes the best choices, closing the current \$3.8 billion deficit would cost up to 30,000 jobs in direct and indirect losses.

An Anchorage legislator complained that his fellow finance members seemed to be playing a budgetary “shell game” after it was revealed the state’s Statutory Budget Reserve savings account contains \$288 million previously thought drained in 2015.

Another member likened it to finding \$288 million in the “couch cushions.” According to Legislative Finance, the money remains because the state cut more spending than assumed in previous fiscal years, and earned more money.

The Alaska House passed an \$8.66 billion state operating budget that cuts \$639.6 million from existing operations. This number allegedly is also 30 percent less than FY15.

The House appropriated \$30 million to develop additional substance abuse services.

\$2,681,000 was restored to Public Broadcasting. This will be a conference committee item since the Senate refused to put it in.

\$450,000 was also added to Home and Community Based Senior Grants. These grants fund non-profit agencies to provide services for physically frail people over the age of 60 and individuals of any age with Alzheimer’s or related disorders.

In the meantime, the Senate Finance Committee 4 to 3, restored \$820,000 to the “Best Beginnings” program and “Parents as Teachers” in their version of the operating budget.

Both programs will be discussed in conference committee since the House didn’t include them.

The Alaska Legislature is blitzing through this year’s budget work at a pace not seen in recent times. But, with 35 days to go, lawmakers still haven’t figured out how to pay for it.

However, legislators in both parties do acknowledge they’ll have to use some of the earnings of the Alaska Permanent Fund, which would lead to reductions in residents’ annual dividend checks.

They still haven’t settled on the details. And, the slew of proposed tax increases on resource industries and consumption to help close the budget gap are taking their time.

Large and small oil companies are fighting **HB 247**, a proposal that would increase oil taxes by about \$100 million and reduce the amount the state is paying in subsidies to oil companies by about \$400 million a year.

## **EDUCATION ISSUES**

Throughout Alaska, Planned Parenthood provides education to about 2,000 students every year. **SB 191** was heard and held in the Senate Education Committee on March 10<sup>th</sup> this past week.

This legislation would restrict the access of abortion services providers to public schools.

While some claim they are indoctrinating our young people, providers come into the classroom to give current and factual health information to build healthy lives. Many have said it is inappropriate for the Legislature to mandate who and how our teachers are to teach.

Opposition to this legislation is overwhelming, with more than 120 pieces of personal correspondence voicing concerns, far less in support.

## **HEALTH & SOCIAL SERVICES ISSUES**

The Alaska Senate voted unanimously to approve a bill to increase the availability of the overdose-prevention drug Naloxone.

The governor will sign senate Bill 23 by Senator Johnny Ellis on March 14<sup>th</sup> in the Capitol at 9:00am.

SB 23 provides legal protection for those providing and administering the drug that stops the physical effect of a heroin or opiate painkiller overdose. It will be easier to obtain and can be in the hands of friends and family members of addicts, not just emergency responders.

A Senate bill to implement major Medicaid reform, SB 74, passed the Senate and was transmitted to the House. The Department of Health and Social Services (DHSS) calculates savings of up to \$33 million in the first year, and up to \$113 million by fiscal year 2022.

The savings, come from reducing unnecessary visits to the emergency room; encouraging increased use of primary care; reducing travel expenses by better coordinating office visits; reducing doctor/pharmacy costs and improper usage of opioids; eliminating user fraud; and increasing access to telemedicine.

## **PUBLIC SAFETY ISSUES**

Marijuana growers could see operation expenses spike if a tax and bond bill (**HB 337**) introduced by an Anchorage lawmaker passes. The bill would punitively tax marijuana grown illegally in the state and add a \$5,000 cash bond requirement for new legal marijuana businesses.

The Alaska Department of Revenue told the House Commerce and Labor Committee they would do a better job of collecting Alaska's marijuana tax with this legislation.

## **NATURAL RESOURCES**

BP will reduce the active rig count at Prudhoe Bay from five to just two, a decision caused by low oil prices and expected to impact oil production and more than 200 contracting jobs.

With prices at their lowest since 2008, the news comes on the heels of several other announcements of job reductions and project delays as companies slash operations in Alaska.

The House Resources Committee is offering two opportunities to weigh-in Monday, March 14 on Governor Walker's proposal to increase oil taxes (**HB 247**) - either from 1 p.m. to 3 p.m., or after normal working hours from 6 p.m. to 8 p.m.

The governor ordered all Alaska state flags be lowered in honor of former First Lady of the United States Nancy Reagan, who passed away this past week at the age of 94. The action follows a proclamation by President Barack Obama to lower all United States flags in honor of Mrs. Reagan.

The Lt. Governor has found that the initiative related to the permanent fund dividend application and the registration of voters was properly filed, and may proceed to the ballot.

If approved by voters, it would instruct the Division of Elections to automatically register qualified Alaskans to vote when applying for the annual Permanent Fund dividend.

The measure will be on the August 16, 2016 primary ballot.
