~ **Operating Budget in limbo as Legislature sorts out how to fund it** ~

HIGHLIGHTS

Juneau's Rep. Sam Kito III has been named House minority whip, succeeding the late Rep. Max Gruenberg.

And, newly appointed Rep. Ivy Spohnholz, was given her committee assignments - House Education, State Affairs, and the House Special Committee on Military and Veterans' Affairs.

A joint session of the Legislature will be convened April 15th to consider the governor's nominees for Boards and Commissions.

Rep. Adam Wool of Fairbanks cautioned that "We don't want to crash the ship" during floor debate on the House operating budget.

The co-chair of Senate Finance has said on numerous occasions he's heard few complaints and assumes previous cuts have not hurt agencies. Yet, the state's largest public school district – Anchorage, is eliminating 49 teaching positions and increasing class sizes.

The University of Alaska has said it will reorganize its campuses and might have to cut more than 8 percent of the staff.

In a move not so common, the Speaker pulled **SB 89** from House Judiciary and instead referred it to the House Health & Social Services Committee. This bill would prohibit a school district from contracting with an abortion services provider.

The parents of a high-profile murder victim are continuing their activism at the Legislature this year, campaigning to defeat a gun bill allowing firearms on university campuses and toughen up a criminal justice reform package.

Butch and Cindy Moore, whose daughter Bree was **shot and killed** by her boyfriend in 2014, are urging lawmakers to stop the progress of **SB 174, SB 91 and SB 89**.

Alaska will get up to **\$170 million** for transportation projects from unused federal earmarks -- funding long ago allocated by Congress for specific projects that were either dropped or finished for less money than was allocated.

The Legislature would save \$7.5 million by moving to the state-owned Atwood Building in Anchorage instead of buying the existing, remodeled office space in the city, according to a new independent report.

Moving would cost \$24.2 million. Issuing bonds to buy their offices on Fourth Avenue at the landlords' \$37 million asking price would produce a \$31.7 million total cost over a 20-year period.

The 20-year cost of keeping the Legislature's existing lease, meanwhile, is \$61.8 million, according to the report.

Stripped last year of most of her committee assignments and staff after voting against the budget, Rep. Lora Reinbold will face Crystal Kennedy in the primary. Ms. Kennedy served nine years on the Anchorage School Board.

BUDGET ISSUES

Co-chairs of the Senate Finance Committee have said they would rather spend down Alaska's big savings accounts than "get into the taxing business."

Likewise, Revenue Commissioner Randall Hoffbeck said he no longer believes a state income tax, one of the keystones of Gov. Walker's fiscal plan, will be implemented in 2016.

With time running out, Governor hopes they at least will tackle the Permanent Fund program revamp.

He may get his wish. SB 128 recently moved from the Senate State Affairs Committee and will be considered by Senate Finance this week. It restructures the \$52 billion Alaska Permanent Fund to help pay for state government.

No matter what plan wins, it will reduce residents' dividends in the process. The question will be: How much?

At 29 pages, **HB 247** isn't the fattest bill of the 29th Legislature, but about 20 hearings have been held so far with more coming.

This bill closes tax loopholes and reforms a subsidy program for the oil companies. It could mean hundreds of thousands of dollars for Alaska.

Led by Co-chair Anna MacKinnon, Senate Finance slashed the Commission of Aging in half. **SB 124** reduced staffing for the commission by two people, one each for the next two fiscal years.

Senator Dunleavy was quoted to say, "It's a process that will occur with every aspect of government because of our fiscal climate. It's got to happen."

Yet, employees have grown by leaps and bounds in the Legislature in the last 20 years under similar leadership.

EDUCATION ISSUES

A bill that would restrict abortion service providers, like Planned Parenthood, from teaching in public schools jumped its first hurdle. The Senate Education Committee voted 3-2, passing an amended version of **SB 191**.

"It seems to me there are a lot of protections in our current system. If a parent does not want their child to receive sex education classes, they can opt out. I think this is state overreach into school boards and into parents. I don't think it's a good bill," as Senator Gary Stevens was quoted.

The other no vote came from Sen. Berta Gardner. "I don't see what problem the bill is solving. If you don't want any talk of abortion in schools, just say so and be done with it."

HEALTH & SOCIAL SERVICES ISSUES

SB 74 the major Medicaid reform bill will be heard almost every day this next week in the House Finance Committee.

Senate Finance heard extensive public testimony on **SB 1**. This bill would prohibit smoking in bars, restaurants and public places across Alaska. Watch for it to pass out of committee as early as March 21st.

Opponents of the proposed ban said it would restrict personal and business freedom. They believe business owners have the right to make their own choices.

Its counterpart – **HB 328** - has hearings in House HSS on March 22 and 24th.

In 2012, the number of Alaska youth or children in foster care was 1,860. That number has skyrocketed to 2,929 this year according to the Office of Children's Services.

For all of those kids, there are only about 1,600 licensed foster homes statewide.

SB 55 has recently seen debate in Senate Labor & Commerce. One side wants to give more freedom to optometrists to perform certain eyes surgeries. The other side, ophthalmologists, insist standards will be lowered for medical and surgical care. The bill is not scheduled this week.

PUBLIC SAFETY ISSUES

SB 91 is a comprehensive criminal justice reform package that will increase public safety, reduce recidivism and is projected by proponents to save the state approximately \$400 million over the next ten years.

This bill incorporates the recommendations of the Alaska Criminal Justice Commission.

Marijuana legislation should move out of committee this next week. **HB 337** is about regulating the industry like alcohol, as intended in the 2014 initiative. House Labor & Commerce has heard this bill twice and will again March 21st.

It provides penalties for unlicensed growers and those growing too much, along with requirements for a surety or cash bond, and to keep records verifying wholesale prices for three years.

According to the Center for Disease Control, heroin and prescription opiates caused more than 47,000 overdose deaths in 2014, while the number of marijuana overdose deaths stayed steady at zero.

NATURAL RESOURCES

In a major reversal, the Obama administration indicated that it would bar oil drilling off America's Atlantic Coast.

However, for Alaska they announced a five-year offshore drilling plan that includes three future lease sales off the coast and six areas in state waters.

The plan by Interior Secretary Sally Jewell covers all potential federal offshore lease sales from 2017 through 2022. The public will have 90 days to comment.
