~ *Presidential Executive Orders are filtering down to Alaska* ~

## HIGHLIGHTS

More executive orders were forthcoming from the president this past week. One of them makes sweeping changes in the way America enforces immigration laws and accepts refugees from abroad. Massive demonstrations were held all over the world, including Alaska.

This past week, Donald Trump nominated Neil Gorsuch for the Supreme Court. Gorsuch is a judge on the Denver-based 10th U.S. Circuit Court of Appeals. He is the youngest (age 49) nominee to the nation's highest court in more than a quarter century, and he could influence the direction of the court for decades.

Carmel Anderson is one of eight artists selected for the Alaska State Museum 2017-2019 Solo Artist Exhibition Series. Her show, *Unheard Voices/Unheard Wisdom*, shares the experiences of victims impacted by domestic violence and sexual abuse. The show features life-size cast and fabric sculptures. [Unheard Voices Unheard Wisdom](#) will be showing at the State Museum through March 18<sup>th</sup>. The show will move to Anchorage and down to Sitka before returning to Ms. Anderson's home community of Ketchikan.

[HB 78](#), which would establish the second Monday in October as "Indigenous Peoples Day," was approved this week by the House and was transmitted to the Senate. The legislation was sponsored by freshman lawmaker Rep. Dean Westlake (D-Kotzebue).

## BUDGET ISSUES

Several reports state we have cut back spending to **2006 levels**. That's ten years ago.

General Fund (GF) outlay for fiscal year (FY) 2013 was \$7.8 billion. For FY 2017 our GF is at \$4.3 billion. The Department of Health & Social Services has been cut by more than 15% during that time.

Reducing the budget is reaching a "point of diminishing returns" as quoted by Speaker Bryce Edgmon. Massive cuts to the Fish & Game budget are already forcing biologists to manage our fisheries more conservatively, thus leading to fewer opportunities across several fisheries leading to less revenue to harvesters, processors, and communities.

Rep. Sam Kito III of Juneau is proposing a special 2.5% income tax on Alaska's lobbyists' income. Kito III said he wants the revenue produced by his legislation to be directed to the Alaska Public Offices Commission (APOC), which oversees state laws related to lobbying and campaign finance.

Construction spending in Alaska is expected to decline again in 2017. The Associated General Contractors of Alaska predicts the total value of "on the street" construction spending this year will be nearly \$6.5 billion, down about 10 percent from last year.

## **HEALTH & SOCIAL SERVICES ISSUES**

Alaska would not benefit by using contractors to run its juvenile jails or the Alaska Psychiatric Institute (API), according to a pair of Legislature-ordered reports on privatization.

Handing over management of API to a private company or a nonprofit would cost more "even after significant staff reductions," according to a letter on the study's findings.

The answer to possibly saving money for juvenile jails was an unqualified – "No." A third ordered privatization study, of the pharmacy that serves the six Alaska Pioneer homes, was never done because no bid met the state's requirements.

Several Bristol Bay organizations are partnering on a new task force to combat drugs, particularly the opioid problem in the region. Bristol Bay Native Corporation (BBNC) President Jason Metrokin said the new body is meant to help find solutions to a problem that has been growing across the state.

The second full month of marijuana tax revenue has entered the state treasury. In December, thirteen marijuana cultivators paid \$145,800 to the Department of Revenue's Tax Division. Under Alaska law, growers pay the state's tax.

Bud is taxed at \$50 per ounce, and other parts of the plant, like the stems and leaves, is taxed at \$15 per ounce.

## **PUBLIC SAFETY ISSUES**

The Legislature will be considering rolling back parts of the state's new crime law that are attracting public and law enforcement condemnation.

Senator Coghill told members of Senate Judiciary that he's drafting legislation that includes proposed amendments to SB 91.

Among other things, the proposed changes would restore jail time for violating bail conditions, shoplifting and first-time low-level felony convictions.

## **NATURAL RESOURCE ISSUES**

Alaska's State Parks director Ben Ellis was dismissed this week. Deputy Parks director Matt Wedeking has been named acting director.

The Alaska Oil and Gas Conservation Commission currently does not issue public notices or hold hearings when an operator applies for a permit to drill a well and uses the "fracking" technique to increase oil and gas production.

Now, the state's oil-well regulator has proposed notifying the public and accepting comments on applications for hydraulic fracturing operations.

On another related note – oil and gas construction spending is expected to drop 15 percent, to \$2.4 billion, compared with 2016.
