## Budget Progress!

~The Legislature & Governor are Starting to Struggle With How to Make Ends Meet ~

### HIGHLIGHTS

The House accepted the Governor's supplemental bill, [House Bill 234](#), passing it this week on a 35-2 vote. If approved, it would be one of the largest spending increases of its kind in state history.

The Governor's bill approves spending \$298.6 million of unrestricted general funds and an overall total of \$526.2 million of state and federal money.

Prior to the vote, Rep. Eastman introduced an amendment that would have removed \$5,000 meant to go to a court settlement with Planned Parenthood. Rep. Eastman went on to discuss abortion rather than specific appropriations within the bill.

After an extended break, Speaker Edgmon called the House back to order and discussion of the bill ended with a near unanimous vote of approval.

Republicans have introduced several anti-abortions bills this session including three introduced Monday. One, [HB 302](#), by Rep. Vance, with 16 co-sponsors, would prohibit abortions after a heartbeat is detected. Other states have introduced similar bills that can ban abortions as early as six weeks into pregnancy.

[HB 283](#), the Born Alive Protection Act by Rasmussen, guarantees medical care to infants that are born alive due to a failed abortion. [HB 284](#) by Rep. Rasmussen, prohibits late term abortions.

Another, [SJR 13](#) by Senator Hughes, proposes an amendment to the Alaska constitution: "To protect life, nothing in this constitution may be construed to secure or protect a right to an abortion or require the state to fund an abortion". Public testimony was taken this week and it's scheduled for its 2<sup>nd</sup> hearing and more **public testimony on Friday, March 6<sup>th</sup> at 1:30pm in SHSS**.

None are expected to pass this year.

A poll by Planned Parenthood conducted in September with 500 Alaskan voters says that 59% identify as pro-choice, including 34% Republicans.

Nearly 8 in 10 don't want to see abortion bans. 58% say women should have access to all forms of reproductive health care options, including abortion.

83% said there should be access to birth control for those who want or need it, including 7 in 10 R's. Almost everybody supports Sex education.

UAA bit the bullet and proposed 19 programs for elimination or suspension in response to last year's big budget cuts. There will be opportunities to talk about it with students and others before the Board makes final decisions in June. Passionate concerns abound.

Corrections Commissioner Nancy Dahlstrom said earlier the State was seeking contracts to house up to 500 inmates outside Alaska, with a possible extension for up to 750. Followed by a big backlash. Since then, they appear to have found several in-state solutions to increase space.

Recall Election signature gathering has officially commenced pending the final judicial decision. Booklets have been delivered and supporters are on the streets.

## **BUDGET ISSUES**

The supplemental bill submitted by the Governor and approved by the House includes:

- \$120 million of state funds and \$143.4 million of federal funds for Medicaid provider payments, spending necessary due to the governor's unsuccessful attempt to implement drastic reductions to the Medicaid program;
- \$8.3 million to restore the Adult Preventive Dental Program, which the governor vetoed last year;
- \$6 million to help the Alaska Psychiatric Institute increase its capacity;
- \$8.6 million to restore Adult Public Assistance to ensure payments for low-income Alaskans, which the governor vetoed last year;
- \$150,000 to re-open the District Attorney's Office in Utqiagvik.
- \$6.7 million for the Department of Public Safety to address a shortfall within the Alaska State Troopers and Alaska Wildlife Troopers due to a lower than expected vacancy rate;
- \$3 million to address the severe damage caused in Anchorage, Kenai, and Mat-Su by the December 2018 earthquake;
- \$7.1 million for the Alaska Marine Highway System to avoid a reduction in the operating schedule for the spring and summer of this year;
- \$110.5 million to pay for wildland firefighting costs incurred last summer and fall;

Meanwhile, **the HFIN committee passed the operating and mental health budgets** from committee on Friday. Both bills may hit the Floor next week.

Goldman Sachs, and now JP Morgan Chase, are saying no to Arctic oil and gas investment citing support for low carbon, clean or cleaner energy. In response, the state dumped a \$1B plan to finance bonds through Goldman to pay off delinquent oil and gas tax credits.

[HB 29](#) by Rep. Spohnholz is now in Senate Rules, ready for a floor vote. It requires health insurers to cover telemedicine services in Alaska. Also good for the economy and should trigger investments in hardware and software by medical providers.
