~ *Federal aid taking over the conversation* ~

HIGHLIGHTS

The new federal COVID-19 money is starting to suck the air out of the room - a one plus billion dollar question. While the Governor made the decisions about how to spend the last \$1 billion gift under the CARES ACT, the Legislature wants in on this one.

“We really do have an opportunity to make a generational change in the economy of Alaska” said Senate President Micciche, according to press accounts. As we noted last week, the timing is tight since the final federal spending rules arrive on May 10 with a legislative adjournment date of May 19.

Dunleavy has submitted his plan for the new money. House Finance just proposed one of their own. The teams seem to be cooperating, but will they need more time?

There are three main categories for the federal \$ mix: infrastructure development (water and sewer, broadband, school repairs): aid to businesses who are hurting; and aid to individuals for things like domestic violence shelter support.

Meanwhile, the House and Senate regular operating and mental health budgets are progressing. The Federal money will be added when the time comes. Overall, the differences aren't that significant, as we understand. The House budget should be on the floor next week.

Foundational PFD issues are also getting some attention. There are several ideas in play with statutory and constitutional proposals for the calculation and distribution of Permanent Fund earnings. But none are likely make it this year and the PFD amount once again will be negotiated at the last minute.

The House just passed [HB 169](#) (26-14) that would fund education ahead of the rest of the state budget through 2023. This would avoid teacher and staff layoff notices required by labor contracts that must be sent when the Legislature goes too far into May.

In a last straw moment, the Senate voted 17-1 to remove Senator Lora Reinbold as chair of the Senate Judiciary Committee. President Micciche said it was all about decorum and mutual respect. Reinbold can have the job back if she starts playing by the rules. They hope so. Senator Holland is her replacement.

Alaska Airlines joined the fray Saturday by banning Senator Reinbold from its flights— pending further review - for continuing to ignore traveler mask rules. The timing could be better since she's now in Southcentral and has to figure out another way to get back to work.

For the first time since March 2020, most Alaska prisons are now open for visits between fully vaccinated prisoners and the public, like family members. Some facilities remain closed due to positive tests.

Vaccine supplies are plentiful, and Alaska will soon have enough of it for every eligible Alaska resident age 16 and over according to Dr. Zink, the state's chief doctor. Still, vaccine rates vary, and they are concerned that vaccine hesitancy may prevent a quick return to normal-ish in some communities.

Reps Carpenter, Vance and Kurka introduced [HB 175](#) COVID-19 Vaccine Rights on the 14th. The bill would prevent businesses and public entities from mandating vaccines as a condition of employment unless required by federal law. It also would ban requiring proof of vaccination to access public areas, services, or benefits. It would not be applicable during a state of emergency.

The Department of Public Safety has given up on their proposal to replace six state run Division of Motor Vehicle offices with private vendors. Rep. Zack Fields had introduced a bill that would block the effort and there has been bi-partisan concern it would increase costs in rural Alaska.

Elon Musk may be coming to the Great Land. As part of a project called "Starlink", SpaceX is considering stations to improve worldwide internet access. Ketchikan, Nome, and Fairbanks are key targets. Their low cost dishes placed around the globe should someday offer high-speed service, even in rural Alaska.

[HB 11](#) Defensive Display of Firearms sponsored by Rep. Rauscher was introduced in February and will receive its first hearing in HCRA. It will also be heard on **Thursday the 29th** when ***public testimony will be taken***. The bill defines “defensive display of firearms” and excludes such displays from violations of third degree assault, fourth degree assault, and reckless endangerment.

The definition includes (A) openly wearing, carrying, or possessing a firearm; (B) verbally informing another person of the possession of a firearm; (C) holding a firearm in a position that does not point the firearm directly at another person; (D) displaying a firearm to dissuade a threatening person; and (E) warning another person of the availability of a firearm to dissuade a threat by the other person.
